

Sub : Rotational Transfer of officials working on Sensitive Posts.

Instructions have been issued from time to time to transfer and rotate officers and staff working on 'Sensitive posts' with a view to check the preponderance of developing vested interests. The extant instructions were reiterated vide Railway Board's letter No. 2017/V-I/ALSL/1/1 dated 04.02.2019.

In a recent review and census of officials working on 'Sensitive Posts', it has been observed that a large number of officers and staff are overstaying on these posts. The position is quite alarming and defeats the very purpose of the entire exercise.

It is, therefore, requested that action may be taken to immediately transfer and rotate all officers and staff who are overstaying on 'Sensitive Posts' in terms of the instructions on the subject. An implementation report on the above may be furnished to the undersigned within 15 days.
