

**Sub:- Uploading of Salary Payment Files on PFMS by 25<sup>th</sup>  
September 2019 for the month of September 2019**

It has come to the notice of this office that Bank Unions have called for a strike from 26<sup>th</sup> September to 27<sup>th</sup> September 2019. Banks are likely to remain closed on those days and even files for the payment of salary for the month of September 2019, which is due for 30<sup>th</sup> September 2019 may not get processed, resulting in delay of disbursement of Salary to the Central Government Employees.

2. All the Pr. CCAs/CCAs/CAs (independent charge) are, therefore, requested to issue necessary instructions to all the field PAOs/CDDOs under their control to **upload the salary payment files for the month of September 2019 with NPB date as 30<sup>th</sup> September 2019 (last working day of the month) and ensure to reach the banks latest by 25<sup>th</sup> September 2019.**
