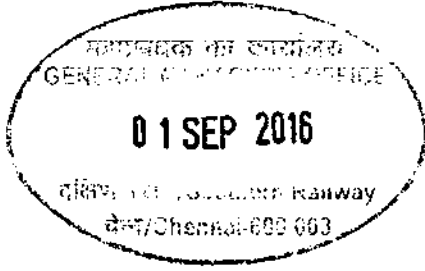

Pensioners Associations as outside bodied (DRM P. S.C.Rly.No SCR/P-GNT/494/1/Qt RPWA dt. 06.07.2011). Rly are exercising subjective discretion in allotment of office accommodation to Pensioners organizations. Some organizations are being discriminated against while some are being favoured.
