It may be noted that under Rule 6(3) of Railway Board's letter dt. 28-07-2016 (RBE 90 /2016) "If the intimation regarding option is not received by the authority within the time specified in Rule 6 (1), the Railway Servant shall be deemed to have elected to be governed by the revised pay structure with effect from the 1st day of January, 2016".

The other conditions under Rule 6 of the above said Board's circular may also be borne in mind while exercising option.

A team involving Staff & Welfare Inspectors (S&WI) may be formed within the Division / Workshop / Unit so that the option & undertaking form is circulated to all the employees concerned individually and all efforts may be made to obtain the same within one month from the date of this order for the speedy implementation of 7th PC.
