Sub: Admissibility of Dearness Relief to pensioners on absorption in  
PSUs/employed family pensioners.

Please refer to Board's letter no. F(E)III/99/PN1/21 dated 5.8.1999 and no. F(E)III/2005/PN1/23 dated 29.09.2009 regarding admissibility of Dearness Relief to re-employed pensioners and employed family pensioners. However, instances have been brought to the notice of Vigilance Directorate by one of the PSUs wherein Dearness Relief on pension is being paid to certain re-employed pensioners not eligible to draw the same as per these instructions **as no endorsement towards non-admissibility of DR was made on their PPOs.**

Kindly review the position prevailing on your Railway/PU streamlining to ensure that instances of irregular drawal of Dearness Relief on pension by re-employed pensioners/employed family pensioners is avoided. Also, a thorough check may be conducted to detect such cases where DR relief on re-employment in Railway PSUs and other organizations has been paid /drawn in violation of the laid down guidelines. Necessary action against defaulting retired Railway Pensioners including necessary recovery may be made and a report furnished to this office.
