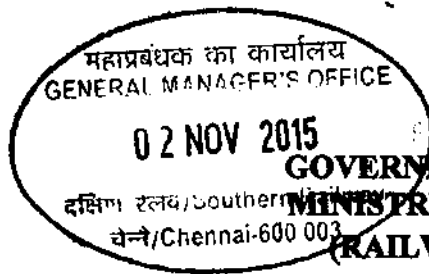

Please refer to Board's letter of even number dated-10.7.2015 issued in partial modification of certain clauses of Board's letter of even number dated 30.6.1998 and Board's letter No. 1996-E(SCT)I/71/5 dated 28.8.1997(RBE. No. 116/97) to the extent mentioned therein due to some basic changes found in the provisional amended Bye-laws of CEC/AIOBCREF (Registration No. S-33475 dated 03.06.2015(Provisional)) circulated to all the Zonal Railways/PUs etc. vide Board's letter of even number dated- 08.07.2015(RBE. No. 76/2015).

Since, the said provisional Amended Bye-laws of CEC/AIOBCREF has been withdrawn vide Board's letter dated 21.10.2015, Board's letter of even number dated 10.7.2015 partially modifying the Board's letter mentioned at para '1' above also stands withdrawn, as if it has not been issued at all. Further, action taken, if any as per the above mentioned Board's letter under reference stands null and void.
