Amended Certificate of Registration No. S-33475 dated 03.06.2015 along with the Amended
Constitution of All India Other Backward Classes Railway Employees Federation
registered(Provisional) on 03.06.2015 was circulated.

2. Now, the matter has been reviewed in terms of the clarification issued vide Registrar of
Farms & Societies, NCT of Delhi's order No. ROS/Society/AIOBCREF/ 2015/ 1716-18 dt.
24.09.2015. Accordingly, it has been decided by the Board that the said provisionally
Amended Bye-laws of CEC/AIOBCREF circulated vide Board's letter under reference may
be withdrawn. As such, the same circulated vide Board's letter of even number dated
8.7.2015 is withdrawn, as if it has not been issued at all. Further, action taken, if any as
per the above mentioned Provisional Bye-laws of CEC/AIOBCREF stands null and void.
