A copy of Railway Board's letter No.PC VI/2008/1/7/2/1 dated 24-09-2015 (RBE No. 115 / 2015) on the above subject is enclosed for information, guidance and necessary action.

Railway Board's letter dated 13-04-2015 (RBE No. 35 / 2015) and 09-09-2008 (RBE No. 106/2008) referred therein have been circulated under PBC No. 43 / 2015 and PBC No. 126 / 2008 respectively. In terms of instructions contained in JPO issued vide PBC No. 148/2011 the arrears of Dearness Allowance due from July 2015 to September 2015 may be arranged for payment to the employees by supplementary bill through normal salary mode of payment i.e., ECS/NEFT/RTGS.


Sub: Payment of Dearness Allowance to Railway employees - Revised rates effective from 01.07.2015.

Please refer to this Ministry's letter of even number dated 13.04.2015 (S.No. PC-VI/349, RBE No. 35/2015) on the subject mentioned above. The President is pleased to decide that the Dearness Allowance payable to Railway employees shall be enhanced from the existing rate of 113% to 119% with effect from 1st July, 2015.

2. The provisions contained in Paras 3, 4 & 5 of this Ministry's letter of even number dated 09.09.2008 (S.No. PC-VI/3, RBE No. 106/2008) shall continue to be applicable while regulating Dearness Allowance under these orders.

3. The additional installment of Dearness Allowance payable under these orders shall be paid in cash to all railway employees. The arrears may be charged to the salary bill and no honorarium is payable for preparing separate bill for this purpose.

4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.




