Sub:- LARSGESS - Regarding counting of qualifying service rendered in the category of Firemen and Shunter.

One of the Zonal Railway has raised the issue as to whether the service rendered by Drivers as Shunters/Firemen, which is a part of the AVC of Drivers, in the last ten years, can be reckoned for determining the eligibility in respect of qualifying service for seeking voluntary retirement under LARSGESS.

2. In terms of Board's letter dated 01.12.2014 (RBE No. 131/2014), for determining the eligibility of employee in respect of the prescribed qualifying service of 33/20 years under LARSGESS, an employee is required to render total qualifying service of 33/20 years, out of which the employee should have rendered at least the last ten years in the concerned safety category post.

3. The issue has been examined in consultation with Establishment Directorate. The category of Shunters is not an identified category for LARSGESS, hence, service rendered by Drivers as Shunters in the last ten years cannot be reckoned for determining the eligibility in respect of qualifying service for seeking Voluntary retirement under LARSGESS. The category of First Fireman has been abolished.
