विषय/Sub : System improvement – Evaluation of answer sheets in Departmental selections – reg.

Ref : Railway Board's letter No. E(NG)I-2005/PM1/16 dt. 27-08-2014 (RBE No. 90 / 2014) circulated under PBC No. 137 / 2014

During the Vigilance Check conducted in one of the divisions in regard to the evaluation of answer sheets in one of the departmental selection, it was noticed that marks were fully awarded to the candidates who have written wrong answers in the descriptive type questions and also to the candidates who have written correctly. It was further noticed that the question setter has not provided the gist / key for the narrative type questions and which alone has lead to the abnormal awarding of marks for the wrong answers also.

It is pointed out that Railway Board vide letter dt. 27-08-2014 (RBE No. 90/2014) cited above have already issued instructions in this regard and the same are to be followed by the question setter for the departmental selection and the said instructions are reproduced here below :


" a) Question paper setters shall make available to the evaluators a gist of the probable answer / important points in respect of narrative type questions."

"b) However, for objective type questions, the question paper setters have to provide exact answer to the evaluators in one word or in a couple of words, as the case may be."

In view of above, it is advised that the instructions of Railway Board as mentioned above should be followed scrupulously without any deviation or violation. It is one of the primary responsibilities of Cadre Personnel Officer to ensure that the question setter has made available all the materials / details required to be furnished by him as stipulated by Railway Board vide letter dt. 27-08-2014 cited above and the same are handed over to the evaluator at the earliest after conduct of written examination, preferably along with handing over of answer sheets.

The Cadre Personnel Officer who is conducting the departmental selection is to ensure that the above procedure is followed strictly and also he / she is to issue necessary instructions in this regard to the selection committee members well in advance.

The above instructions should be adhered to strictly without any deviation or violation.
