(i)	Para 9.2.6 of letter No. 2010/E(Sports)/4(1)/1(Policy) dated 31.12.2010 (RBE No. 1898/2010)  No out-of-turn promotion shall be granted during probation period.	If a sportsperson acquires the norms for out of turn promotion, except the condition of completion of probation, in such case, the promotion may be granted and the balance probationary period be reckoned in the higher grade, in which the promotion is proposed to be carried out.
