Sub: Grant of Residential Card Pass or alternatively one-third concession season pass to the Railway employees of Car Shed at Velachery, Chennai Division, Southern Railway.

Ref:- Your letter No.1/15/Part.III dated 22.12.2014.

The matter has been examined in consultation with Finance Dte. It has been decided that Residential Card pass may not be extended over any section in view of grant of transport allowance to Railway employees.

Attention in this connection is also invited to Board's letter No.PC-V/2008/A/TA/2 dated 23.01.09 indicating that transport allowance be made admissible to those railway employees who are already availing the RCP facility with a proviso that no further railway or section will be added to the ambit of RCP, in future.

As regards, request for 1/3 concession on seasonal passes and allowing privilege passes over MRTS section between Chennai Beach to Velachery Section, the same also have not been found feasible of acceptance due to financial and other implications.
