References have been received from various RRBs and RRCs seeking clarifications as to whether the rates prescribed vide letter No. E(G) 2006/ HO1-14 dated 7.2.2014 are also applicable to RPF personnel deployed for RRB and RRC written examination and PET.

2) The matter has been considered by the Board and it is clarified that the rates prescribed in Board's letter dated 7.2.2014 are also applicable for the following:-

- I) RPF personnel deployed for written examination conducted by the RRCs.
- II) RPF personnel deployed for the PET conducted by RRCs.
- III) RPF personnel deployed for the written examination conducted by RRBs.

3) The rates will be effective from 7.2.2014 ie. the date of the issue of Board's letter No. E(G) 2006/ HO1-14 Dt. 7.2.2014.
