Requirement of Life Certificate at the time of First credit of pension

At present the banks are insisting on pensioners to physically appear in the banks to prove their existence before commencing first payment of pension. We have been advised by Government of India, Ministry of Railways (Railway Board) that the instructions issued by CPAO vide Office Memoranda No. CPAO/ Tech/Simplification/2014-15/52 and CPAO/Tech/Life Certificate/2014-15/130 dated May 28, 2014 and July 28, 2014 (copies enclosed) are applicable to the Railway pension payments also. You are, therefore, requested to issue suitable instructions to your CPPC/pension disbursing branches in the matter.

Sub: Requirement of Life Certificate at the time of first credit of pension.

At present the banks are insisting on pensioners to physically appear in the bank to prove their existence to enable the bank authorities for issue of Life Certificate before commencing first payment of pension. In this regard, CPAO/Dept of Expenditure, M/o Finance vide OM no. CPAO/Tech/Life Certificate/2014-15/130 dated 28.07.2014 has clarified that as per the existing arrangement, no provision of submission of life certificate at the time of first credit of pension is available. Further, vide O.M. dated 28.05.2014, physical presence in the paying branch is no longer required for identification of pension and the bank has to identify the pensioner with reference to the information already available with bank obtained through KYC at the time of opening of bank account (copy enclosed).

It is requested to issue suitable instructions to all the PSBs in this regard so that there are no delays on this account in commencement of pension.

A copy of the instructions issued may be endorsed to this Ministry also for circulation amongst the Zonal Railways.
