

Sub.: Filling up of backlog of reserved vacancies/posts in promotion quota through Special Promotion Drive by temporary down-gradation to lower grades due to non-availability of SC/ST candidates.

In pursuance of the meeting held on 22.07.2014 under the chairmanship of the Secretary/DOP&T to monitor the filling up of backlog vacancies of SCs/STs in promotion quota, it has been decided that where reserved vacancies of promotional quota could not be filled up due to non-availability of SC/ST candidates in one or two grades below; such vacancies may be downgraded to the recruitment category/grade and filled up through RRB/RRC so that required number of SC/ST candidates become available for promotion in future.
