In terms of Board's instruction referred to above, Southern Railway vide its letter No.P(W)641/1/7/CSBF DL(Pt) dated 07-07-2014 has sought clarification whether the total numbers of representative from SRMU, the single recognized union on Southern Railway, can continue to be six or otherwise.

In this regard it is clarified that clauses as mentioned in Board's letter ibid have been added to the existing provisions contained in Rule-807 & Rule-808. One representative each from All India Scheduled Castes & Scheduled Tribes Railway Employees Association (AISC & STREA) and All India OBC Railway Employees' Association have been included at Zonal Railway & divisional level in addition to six and two representatives of recognised Federations at Zonal & Divisional level respectively.



As per the Advance correction slip No.122 circulated by Board vide letter under reference, one representative each from All India Scheduled Castes & Scheduled Tribes Railway Employees' Association (AISC&STREA) and All India OBC Railway Employees' Association (AIOBCREA) are to be included in the Staff Benefit Fund Committee both at Zonal level (clause vi of Rule 108) and Divisional level (clause iv of Rule 808) and accordingly the above orders are being implemented.

As per the existing provision, (clause v Rule 807 of IREM Chapter-8) 'Six members shall be from recognized unions, to be equally divided amongst the recognized unions'. This rule provision does not envisage a situation of single recognized union. On this Railway there is only one recognized union (SRMU) and all the six members at Zonal level and all the four members at Divisional level are nominated by the same union.

In the above context, where one representative each from AISC&STREA & AIOBCREA are to be included, Board are requested to clarify whether the total no. of representatives from SRMU can continue to be six or otherwise.
