The issue regarding diversion of one third (33-1/3%) of
vacancies of directly recruited Junior Accounts Assistants for
promotion of Appendix-II IREM qualified Accounts staff was under
consideration of Ministry of Railways for quite some time.

2. After careful consideration, it has now been decided, as a one-
time measure, to fill up one third (33-1/3%) of the direct recruitments
posts of Junior Accounts Assistants from Appendix-II IREM qualified
Accounts staff or the number of the posts equal to the number of
Appendix-II IREM qualified Accounts staff available and eligible for
promotion as on date, whichever is lower.

3. This disposes off the references received from East Coast,
Northern, North Central, Northeast Frontier, South Central, South
Western, Southern Railways and ICF on the above subject.
