Sub: Implementation of the provisions of "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013".

Kindly refer to Executive Director(IR)'s letter of even number dated 05.12.2013 sending therewith a copy of the **Prohibition of Employment as Manual Scavenger and their Rehabilitation Act, 2013** for issuing detailed guidelines in order to comply the provisions of the Act.

2. Ministry of Social Justice & Empowerment, the nodal Ministry desires that the Railway Administration should take immediate steps to implement the provisions of the Act.
3. Board have decided to nominate 'Additional Divisional Railway Manager' for the jurisdiction of respective Divisions & for Institutes, Workshops, Shed etc. falling in Division's jurisdiction, SAG/JAG officer of the Department maintaining the sanitation for the jurisdiction of respective Production Units/ RDSO" in terms of sub-clause(m) of sub-section(1) of Section 2 of the aforesaid Act.
4. Further in terms of Section 20 (1), Health/Commercial Inspectors wherever assigned the duties of monitoring cleanliness, are hereby vested with the powers, within their jurisdiction which would be decided by the officer nominated by 'Additional Divisional Railway Manager' in the division and Senior Administrative Grade/Junior Administrative Grade officer of the Department maintaining the sanitation for the jurisdiction of respective Production Units/ Research Designs & Standard Organisation
5. Railways are requested to ensure by 28th February, 2014 positively that there is no violation of any provisions of the Act.
