The above referred issue has been under consideration in consultation with AIRF and NFIR.

2. Accordingly, it has been decided that all erstwhile Group 'D' categories in G.P. Rs.1800, since upgraded as Group 'C', will continue to be eligible for selection to Group 'C' posts as per the AVC already provided, if they possess the required eligibility criteria i.e. prescribed educational qualification and residency period etc. They will also be eligible for being considered for promotion to the post of Stenographers (G.P. Rs.2400), if they possess the required eligibility criteria.
