Attention is invited to Board's letter of even number dated 9.5.2022 whereby Officers/Staff on deputation to DFCCIL were permitted to retain Railway accommodation at the place of their previous posting upto 30.6.2023.

On consideration of a request received from DFCCIL and in exercise of powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, the Full Board have decided that Railway officers/staff on deputation to DFCCIL and occupying Railway accommodation may retain Railway accommodation for a further period of one year beyond 30.6.2023 i.e. upto 30.6.2024 on the same terms and conditions as contained in Board's letter dated 9.5.2022 referred to ibid.
