Sub: Single Stage examination for filling up the posts of Console Operator  
(both PRS & UTS).

As the Railway administration are aware, the posts of Console Operators (both PRS & UTS) are being filled up as per instructions contained in Railway Board's letter No. E(NG)I/87/PM 16/3 dated 15.02.1993.

On a reference from one of the Zonal Railways, the procedure enumerated in the aforesaid instructions for filling up the posts of Console Operators has been reviewed in consultation with the Commercial Directorate and it has been decided that henceforth a single stage examination (duly including questions on Aptitude Test/Computer knowledge) may be conducted as part of selection procedure for filling up the posts of Console Operator (both PRS & UTS). This examination may preferably be conducted in 'online'/CBT mode.
