

**Chapter 9**

**Provident Fund Rules:**

**ADVANCE CORRECTION SLIP No.:- 144**

1. In Rule 905, after sub-rule (2), the following sub-rule shall be inserted, namely:-

“(3) The amount of subscription fixed under Rule 909 and fixed or reduced or enhanced under sub-rule (2) shall be subject to limit specified in the second proviso to sub-rule (1) of Rule 909.”
2. In Rule 908, the following proviso shall be inserted, namely:-

“Provided that the sum of the monthly subscriptions during a financial year together with the amount of arrear subscriptions deposited in that financial year shall not exceed the limit as specified in the second proviso to sub-rule (1) of Rule 909”
3. In Rule 909, in sub-rule (1), after the proviso, the following proviso shall be inserted, namely:-

“Provided further that:-

the sum of monthly subscriptions in a financial year shall not exceed the threshold limit referred to in sub-clause (i) of clause (c) of the Explanation below sub-rule (2) of rule 9D of the Income Tax Rules, 1962”
4. In Rule 910, in sub-rule (3), after the proviso, the following proviso shall be inserted, namely:-

“Provided further that the sum of the monthly subscriptions during a financial year together with arrears of subscription and the interest thereon recovered in that financial year shall, in no case, exceed the limit as specified in the second proviso to sub-rule (1) of Rule 909.”
