Recruitment of sportspersons in the erstwhile Group 'D' quota allotted in Grade Pay Rs. 1800/- (as per 6th CPC) was frozen for the year 2016-17 vide this office's letter no. 2015/E(Sports)/4(1)/11 dated 25.05.2016 and the freeze was continued in subsequent years.

2. The matter has been reviewed and Ministry of Railways (Railway Boord) have decided to restart the recruitment in Pay Level-1 (in GP Rs. 1800/- as per 6th CPC) against the sports quota berths allotted to Railways & Production Units (Erstwhile Group D Category) with following revision in sports norms as contained in Board's letter referred (i) above and clarification /corrigendum issued thereto:
