> Sub: Rate of Dearness Allowance applicable w.e.f. 01.07.2022 to those Railway employees who continue to draw their pay in the pre-revised pay scale/ grade pay as per 6th Central Pay Commission.

Please refer to this Ministry's letter of even number dated 11.05.2022 (PC-VI/407 RBE No.56/2022) revising the rates of Dearness Allowance w.e.f. 01.07.2021 & 01.01.2022 in respect of railway employees continuing to draw their pay in the pre-revised pay scale/ grade pay as per 6th Central Pay Commission.

- The rate of DA admissible to railway employees of above category shall be enhanced from the existing rate of 203% to 212% w.e.f. 01.07.2022.
- The provisions contained in Paras 3, 4 & 5 of this Ministry's letter of even number dated 3. 09.09.2008 (S.No. PC-VI/3, RBE No.106/2008) shall continue to be applicable while regulating Dearness Allowance under these orders.
