**Sub: Recruitment under Cultural and Scouts & Guides Quota for Year-
2019-20- grant of extension of time regarding.**

Multiple Railways/PUs have requested Board to grant extension beyond 31.03.2020 for completion of recruitment process under the Cultural and the Scouts & Guides Quotas for the FY 2019-20 which though initiated in the FY 2019-20 could not be completed due to various preventive measures taken for containing the spread of COVID-19.

2. The matter has been examined and it has been decided to extend the time by six months to 30.09.2020 for completing the recruitment process where written tests have already been conducted for making recruitment under these Quotas for the FY 2019-20.

3. Recruitment under these Quotas for the FY 2020-21 may, however, be pended in view of austerity measures. Final decision in this regard will be taken as the situation normalizes post COVID-19 pandemic.


