The following guidelines are issued with regard to the implementation of the orders of Railway Board on Cadre Restructuring for the Unified Cadre of Track Maintainers:


1. The Cadre of Track Maintainer was re-structured as under w.e.f 17/08/2012:

| Sl. No | Designation          | Pay Structure   | Percentage Distribution of Posts |
|--------|----------------------|-----------------|----------------------------------|
| 1      | Track Maintainer-I   | PB-1 GP Rs.2800 | 3                                |
| 2      | Track Maintainer-II  | PB-1 GP Rs.2400 | 6                                |
| 3      | Track Maintainer-III | PB-1 GP Rs.1900 | 20                               |
| 4      | Track Maintainer-IV  | PB-1 GP Rs.1800 | 71                               |

2. The revised percentage of distribution of the posts as above, will be effected w.e.f 17/08/2012, as per RBE No.91/2012 (PBC No.119/2012).
3. For promotion against the posts during the period from 17/08/2012 to 12/08/2013, the procedure laid down in Sub Para (i) to (iv) of Para 1 of Board's letter dated 17/08/2012 should be followed.
4. Railway Board have communicated the mode of promotion to be adhered to in the Unified Cadre of Track Maintainer vide their letter dated 13/08/2013 (RBE No.81/2013 – PBC No.104/2013).

5. The above instructions of Board's letter dated 13/08/2013 should be followed for promotion to be effected from 13/08/2013.
