Subject :-Kilometrage Allowance and Allowance in lieu of Kilometrage (ALK) of Mechanical Brakesmen working on Nilgiri Mountain Railway/Salem Division of Southern Railway – Revision w.e.f. 1-1-2011.

In terms of Board's letter No. E(P&A)-II/2005/RS-34 dated 28-06-2012, the rates of Kilometrage Allowance (per 100 kms) and the rates of ALK (per 160 kms) which were laid down vide Board's letter No. E(P&A)-II/2005/RS-34 dated 26-12-2008 has been increased by 25% with effect from 01-01-2011. Consequently, the rates of KMA/ALK for Sr. Mechanical Brakesman and Mechanical Brakesman of the Nilgiri Mountain Railway/Salem Division of Southern Railway, as given in Board's letter of even no. dated 25-08-2009 may also be increased by 25% with effect from 01-01-2011.

Sub: Pay element in Running Allowance in the Railway Services (Revised Pay) Rules, 2008 and revised rates of Kilometreage Allowance and Allowance in lieu of kilometreage.

Ref: Southern Railway's letter no. P(S)483/VI/OA 789/2006/CAT/ERS dated 29.5.2009.

In reference to Southern Railway's letter quoted above, the Board have decided that in respect of Mechanical Brakesman and Sr. Mechanical Brakesmen of Nilgiri Mountain Railway, Running Allowance and Allowance in lieu of kilometreage shall be admissible at the rates indicated below:-

S.No.	Category Pay Band/Grade Pay	Rates of Running Allowance/100 Kms. (in Rs.)	Rates of Allowance in Lieu of kilometreage (160 Kms.) (in Rs.)
1.	Sr. Mechanical Brakesmen (5200-20200/2400)	126.00	202.00
2.	Mechanical Brakesmen (5200-20200/1900)	121.00	194.00

2. These orders shall take effect from the date of issue of this letter.
3. Kilometreage Allowance paid at higher rates to the Mechanical Brakesmen and Sr. Mechanical Brakesmen of Nilgiri Mountain Railways till June 2005 may be protected. No arrears at the higher rates will be payable for the period from July'05 till date of issue of this letter.
4. This has the sanction of the President and issues with the concurrence of the Finance Directorate of the Ministry of Railways.
