Sub: Recruitment of persons with disabilities-Medical Examination-reg.

Attention is invited to this Ministry's letter No. E(NG)II/2009/5 List dated 27.8.2009, circulating therewith the Department-wise list of posts identified as suitable for persons with disabilities (PWDs) in non-gazetted categories on the Railways, to give effect to 3% reservation to persons with disabilities for recruitment from open market.

It has been observed that while sending the PWDs for medical examination, the memos being issued by the concerned department are not as per the standard laid down procedure as they mention the medical category such as A1 or A2 etc. designation and department containing the heading as "physically handicapped, visually handicapped or hearing handicapped etc.

Accordingly, the matter has been looked into and it has been decided that following procedure be followed:-

- (i) the recruiting department has to issue Medical memos mentioning the department, the category of post (Group C or erstwhile Group D alongwith their Grade Pay) and category of disability required to be examined like OL, OA, BL, OAL, OH, BH, HH, BL, LV, MW etc. Medical categories like A1, A2 etc. should NOT be mentioned on this memo.
- (ii) The examining Doctor will issue certificate to the effect that candidate is fit under handicapped quota under OL, OA, BL, OAL, OHetc. This certificate will not and can not mention any medical category.
