

**Sub: Retro-fitting of AC on staff cars.**

Instructions contained in Board's letter No. E(G)2007/AL 4-6 dated 8/8/2007 and 30/9/2008 specify the officers entitled to the exclusive use of a staff car.

It has been observed that prior to the issue of these instructions some SAG officers were also using exclusive non AC staff cars many of which still continue to be in use.

It has now been decided by the Board that such non AC vehicles which continue to be in use on the Railways by the SAG officers may be retro-fitted with AC.

The retro-fitting of AC on such vehicles may be done after taking into consideration the condition of the vehicle and its remaining useful life and also keeping in view the stipulation that as far as possible, for officers in the SAG rank, hiring of vehicles may be resorted to in terms of instructions contained in Board's letter No. F(X)II/2006/PW/11 dated 7/15-5-2007 and 28-5-2008.
