Sub: Dispensation of Written Test for recruitment of wards under LARSGESS.

The employees' Federations have been demanding dispensation of Written Examination for recruitment of wards under LARSGESS for quite some time. The matter has been considered by the Board and it has been decided to dispense with Written Examination for recruitment of wards of Gangmen and the specified Safety categories in GP ₹ 1800/- as notified in Board's letters of even number dated 11.09.2010 and 03.01.2012 under LARSGESS. However, they will have to qualify the medical tests for the relevant category/posts, after verification of educational certificates etc. by a Committee of three JAG level officers at Divisional level.

2. These instructions are applicable from July - December 2013 retirement/recruitment cycle onwards only. The past cycles will be governed by the earlier instructions.
3. The other terms and conditions of the Scheme will remain the same.
