During the PNM meeting held on 5<sup>th</sup> - 6<sup>th</sup> June/2012 NFIR had brought out that the Zonal Railways/Units are not making full use of the facility/provision of Replacement Panels. Due to this reason, the vacancies remain unfilled and at the same time, money & resources are wasted in conducting fresh recruitment. In this connection, NFIR had suggested that the existing instructions on the same should be reiterated so that Replacement Panels lying with RRBs are fully utilized by the Zonal Railways.

2. As per the existing instructions contained in Board's letter dated 07.07.2009 under reference above, 30 % extra candidates are kept on wait list who are called for documents verification by the RRBs so as to meet the requirement of replacement panels. It was also advised therein that Railways/Units must make full use of the provisions of these Replacement panels. For this whenever a fresh indent is placed on RRB, Zonal Railways/Units should also certify that the previous panel for the post has been exhausted and also the provision for Replacement Panel has been fully made use of.

3. The matter regarding currency/operation of RRB panels and utilization of replacement panel has been deliberated in Board's office and it is desired that the Zonal Railways/Units should adhere to the existing instructions on the subject scrupulously.
