
Sub:-Order dated 04.01.2012 of Hon'ble Delhi High Court in C.P.No. 311/2009 arising from W.P. No. 566/200, All India Shramik and Coach Attendants Association & Ors. Vs. UOI & Ors.

Please refer to Board's letter of even no. dated 24.02.2012 whereby Board's decision to comply with the order dated 04.01.12 of Hon'ble Delhi High Court in the above cited matter duly reproducing therein the directions of Hon'ble High Court has been communicated. During the last date of hearing i.e 16.01.2013 in the C.P. the petitioners pointed out that the beneficiary of the Court's order are not being designated as Passenger Attendant (Grade-1) and are not being accorded Group "C" status as directed by the Hon'ble High Court in their order.

2. In the above context its advised that while allowing the revised pay scale to Coach Attendants as per Court's directions the beneficiary may also please be designated as Passenger Attendant Grade-I. Further, by virtue of the grant of said revised pay scale, the beneficiary stands classified as Group "C" as per the extant instructions regarding classification of posts prevailing at the time of successive Pay Commissions.

3. It is, therefore, advised that while implementing the order dated 04.01.12 of Hon'ble Delhi High Court the position brought out in para 2 above may please be adhered to.

4. This may be treated as **most immediate**.
