
Sub: Carrying out MPP processes through HRMS only.

Railways/PUs have been directed to carry out all the MPP related processes i.e. creation, crew review, redistribution, surrender etc. through HRMS only. However, it has come to notice that many Railways & PUs are still carrying out these processes outside of HRMS or in dual mode.

2. Dual or multiple modes of MPP transactions have resulted in mis-match of manpower data in HRMS vis-a-vis the monthly PCDO figures obtained from MPP portal.

3. Accuracy in manpower data is important in several management decision making processes and policy initiatives at Railway Board level. Further, manpower data is also furnished to different constitutional and statutory authorities. It is therefore essential to avoid data mis-match from different sources.

4. General Managers are requested to direct the PCPOs and other HODs including Finance and Security to ensure correct data entry and updation in HRMS and also adhere to Board's directions of carrying out all MPP processes through HRMS only.
