Sub: Notifications dated 21.11.2025 issued by Ministry of Labour and Employment regarding Labour Codes

The following four codes were notified by the Ministry of Law and Justice (Legislative Department) in the year 2019/2020:

- (i) The Code on Wages, 2019 (notified on 08.08.2019);
- (ii) The Industrial Relations Code, 2020 (notified on 29.09.2020);
- (iii) The Code on Social Security, 2020 (notified on 29.09.2020); and
- (iv) The Occupational Safety, Health and Working Conditions Code, 2020 (notified on 29.09.2020).
- 2. The provisions of the above codes have been made effective w.e.f. 21.11.2025 vide Notifications dated 21.11.2025 issued by Ministry of Labour and Employment (copies enclosed). The complete provisions of the codes have been made effective in respect of The Industrial Relations Code and The Occupational Safety, Health and Working Conditions Code. The provisions in respect of the other two codes (Code on Wages and Code on Social Security) have been made effective partially.
- The Rules on the above Labour Codes are expected after the mandatory 45 days of notification in the Gazette.
- 4. The Zonal Railways/PUs are advised to conduct workshops and familiarise themselves with the codes so as to act as a guiding force for field officers. Dialogues may also be conducted between Unions and management for seeking their cooperation in smooth implementation of these codes, as well as ensuring transparency, clarifying misconceptions, and building confidence.
- 5. Key information related to the Codes may be disseminated to all stakeholders to create a clear understanding among railway workers and service providers. Field level officers may engage with workers for last mile outreach.
