
A platform called "Anubhav" has been introduced by the Department of Pension and Pensioners' Welfare (DoP&PW) whereby retiring/retired Government servants can upload a write up showcasing outstanding work done by them during service period. Under the said scheme, Central Government employees, Central Public Sector Enterprises (CPSEs) employees and Public Sector Bank employees can submit their experiences while working with the Government through Anubhav Writeups from 8 months prior to retirement and upto 3 years after retirement. All write-ups submitted upto 31.03.2026 shall be eligible to be considered for National Anubhav Awards, 2026.

2. In this connection, DoP&PW's OM No. 4/01/2025-P&PW(CPEN) dated 29.09.2025 enclosing therewith National Anubhav Awards Scheme, 2026 has already been circulated vide Board's letter dated 07.10.2025 under reference. Despite the extant instructions, the new write ups are very less from Ministry of Railways.

3. It has been desired by DoP&PW that special impetus will be on maximizing the Anubhav Write-ups from the officers having Pay level 15 and above. To encourage retirees/retiring employees, DoP&PW has prepared a booklet (copy enclosed) in the form of PPT containing the basic details of the scheme, process of filing the write-up and a draft invitation which may be sent to each retiring official/staff.

4. In view of the above, it is requested to kindly direct the concerned officers to put in their best efforts to encourage eligible employees to submit their Anubhav write-ups in timely manner in order to be considered for National Anubhav Awards, 2026. Concerned officers may also be directed to clear the pending write-ups as reflected under the head - 'Write-ups yet to be Published' on the portal. The efforts undertaken being monitored through google sheet (link: https://docs.google.com/spreadsheets/d/1rNzpZNjrq-aSCjMWmKU9X_TyYtTAiHqgfkSPcNvEbA/edit?usp=sharing), may also be updated on regular basis. A line of confirmation will be highly appreciated.

A platform called "Anubhav" has been introduced by the Department of Pension and Pensioners' Welfare (DoP&PW) whereby retiring/retired Government servants can upload a write up showcasing outstanding work done by them during service period.

2. In this connection, please find enclosed herewith a copy of DoP&PW's OM No. 4/01/2025-P&PW(CPEN) dated 29.09.2025 enclosing therewith National Anubhav Awards Scheme, 2026 launched by Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioner's Welfare. Under the said scheme, Central Government employees, Central Public Sector Enterprises (CPSEs) employees and Public Sector Bank employees can submit their experiences while working with the Government through Anubhav Writeups from 8 months prior to retirement and upto 3 years after retirement. All write-ups submitted from 01.04.2025 up to 31.03.2026 shall be eligible to be considered for National Anubhav Awards, 2026.

3. It is further requested that wide publicity be given to the said scheme as suggested by DoP&PW so that the guidelines issued by DoP&PW may be circulated amongst all employees/retirees as well as attached subordinate offices for encouraging more employees participation in submitting their Anubhav experiences.

4. It is further advised that equivalence of pay scales between central Government employees as well as employees of Railway PSUs for the purpose of eligibility of National Anubhav Awards Scheme, 2026 are applicable as contained in DoP&PW's OM dated 06.02.2025 circulated by Board's letter of even no. dated 25.02.2025 (copy enclosed) till further orders.

विषय: Measures for enhancing the publication of Anubhav write-ups under National Anubhav Outreach Program, 2025-26-reg.

The Anubhav Portal was launched in March, 2015 for sharing of their experiences (Anubhav) by retiring and retired government employees in pursuance of directions of Hon'ble Prime Minister.

2. The National Anubhav Awards Scheme, 2026 (copy attached) has been notified and it provides opportunity to the employees to submit their experiences within the time period starting from 8 months prior to their retirement and upto 3 years of the their retirement. Top 05 write-ups will be conferred with National Anubhav Awards and other 10 write-ups will be conferred with Jury certificates.
3. In order to maximize the number of write-ups, following action may be undertaken:-
 - i. The concerned Authorities may issue written communications, preferably in regional languages, encouraging the employees retiring in next 2 months, to share their experiences as per the marking system, contained in para 6 of the scheme.
 - ii. In the farewell functions of the retiring employees, adequate publicity of the scheme and benefits of submitting the write-ups may be done.
 - iii. The retiring employees who have submitted the write-ups may be issued Certificates, appreciating their efforts.
 - iv. An awareness Campaign on the similar lines may be undertaken in the CPSEs, if any, under the administrative control of your Ministry/Department.
 - v. Proactive action may be taken on the write-ups under 'Write-ups-yet-to-be-published' category.
 - vi. The compliance report of the above mentioned initiatives may be filled in the Google sheet by the seventh of each month (https://docs.google.com/spreadsheets/d/1rNzpZNjru-aSCjMWmKU9X_TyYtTAiJHqgfkSPeNvEbA/edit?usp=sharing).

NATIONAL ANUBHAV AWARDS SCHEME, 2026

On the directions of the Hon'ble Prime Minister of India, Department of Pension & Pensioners' Welfare had launched an online platform 'Anubhav' in March 2015 for sharing the experiences of retiring/retired government employees while working with the Government. It is a scheme for retiring/retired employees to showcase their significant achievements during service period. The platform serves as a repository of practical insights and replicable best practices that can guide and inform future governance. This will prove an invaluable tool for documenting the administrative history of India through personal memoirs.

2. Thereafter, an Annual Awards Scheme to incentivize and encourage retiring/retired employees to submit their experience through write-ups was introduced in 2015. 59 Anubhav Awards and 19 Jury Certificates have been conferred till 2024 and 5 Anubhav Awards and 10 Jury Certificates for 2025 will be conferred. Further, enriching the 'Anubhav' initiative, the Department of Pension & Pensioners' Welfare (DOPPW) organizes a monthly webinar series titled 'Anubhav Awardees' Speak'. This platform features selected awardees who have contributed exceptional write-ups to the Anubhav portal. Through these sessions, awardees share their insightful experiences, innovative practices, and noteworthy contributions made during their tenure in government service. Hitherto, 21 webinars have been held in which 30 Awardees have presented their experiences.

3. NATIONAL ANUBHAV AWARDS SCHEME, 2026

3.1 For the year 2026, the scheme aims to recognize the contribution of eligible Government employees in the following categories:

- i. Accounts
- ii. Administration
- iii. Good Governance
- iv. Government process re-engineering
- v. Information Technology
- vi. Research
- vii. Simplification of procedures
- viii. Learning from Failures
- ix. Public Dealing
- x. Contribution to his/her field work
- xi. Instances of great strength/valor/bravery
- xii. Constructive feedback or suggestion to improve the line of work, he/she was part of; and
- xiii. Any other category decided by the Committee

3.2 For the year 2026, it has been decided to confer Anubhav Awards to 5 (five) best write-ups and 10 (ten) Jury Certificates will be presented to other outstanding write-ups to promote wider publicity and participation in National Anubhav Awards scheme, 2026. Assessment of the write-ups would be structured on premises as stated in para 6 of the Scheme.

3.3 The Awards shall be conferred by Hon'ble MOS (PP) at a National Level event.

4. ELIGIBILITY

The employees of Central Government, Central Public Sector Enterprises (CPSEs) and Public Sector Banks who are going to retire in next 8 months or who have retired within 3 years are the 'eligible employees' for the submission of Anubhav write ups. All the Anubhav write-ups published on the Anubhav Portal between the period 1st April, 2025 and 31st March, 2026 will be considered for the Anubhav Awards/Jury Certificates, 2026 under National Anubhav Awards Scheme, 2026.

5. ROLE AND RESPONSIBILITIES OF THE MINISTRY/DEPARTMENT/ORGANISATION

5.1 Initiatives should be taken to sensitize the retiring or retired employee for submitting their write-ups through SMSs and emails. FAQs, steps to fill Anubhav write-up, selected write-ups for guidance, short film on Anubhav Awardees and citation booklets have been put up on the Anubhav Portal. Their adequate publicity may be done amongst the eligible employees.

5.2 The HOOs and HODs should act upon the write-ups reflected under the head- 'Write-ups Yet to be Published' on the Anubhav Portal on regular basis.

5.3 HOO and HOD may refer the FAQs put up under the Head- 'Organization' on the Portal.

6. PROCESS OF SHORTLISTING ANUBHAV AWARDS AND JURY CERTIFICATES

Step 1- The eligible retiring or retired government employee can visit the Anubhav Portal at the following URL: <https://pensionersportal.gov.in/Anubhav/>. Thereafter, basic details along with the write-ups, not in more than 5,000 words and appropriate attachments, wherever required, shall be submitted by the retiring/retired government employee on the Portal. At this stage, the write ups will be visible under the category of 'Write-ups yet to be published' on the Anubhav Portal.

Step 2- The write ups so submitted shall be assessed and approved by concerned Ministry/Department/Organization. After approval, the write-ups shall be visible under the category of 'Write-ups published' on the Anubhav Portal.

Step 3- Selection process: The published write-ups will be divided into three categories and the same would be examined for 05 Anubhav Awards and 10 Jury certificates. The category wise division of the Anubhav Awards and Jury Certificates is as under:

Thereafter, the write-ups will be subjected to 2- tier examination.

Tier-I: Screening of the published write ups shall be done by the Screening Committee(s) in the Department of Pension & Pensioners' Welfare. In this process, the write-ups will be examined on following criteria:

Tier-II: Next round of shortlisting for the 5 (five) Anubhav Awards and 10 Jury Certificates shall be done by an Evaluation Committee (EC), chaired by the Joint/Additional Secretary (Pension & PW). The Composition of Evaluation Committee (EC) is as below:

Step 4- Evaluation Committee will finalize name of awardees and later 'No Objection Certificates' (NOCs) of the selected awardees will be obtained from concerned Ministry/ Department/Organization and IB.

Step 5- Recommendations of the Evaluation Committee, after approval of Secretary (Pension & PW) and necessary clearances, shall be put up to the Hon'ble MOS (PP) for approval.


7. DETAILS OF AWARD AND OTHER ENTITLEMENTS

7.1 Each Anubhav Awardee will be felicitated with a Medal, a Certificate and a Cash Prize of Rs. 10,000/- (remitted through digital transfer to Awardees account) whereas a Jury Certificate Winner will be presented with a Medal and a Certificate.

7.2 Travelling Allowance: TA to the Anubhav Awardee/Jury Certificate Winner (as per last entitlement) and one accompanying person, travelling for Award ceremony to New Delhi and back, will be reimbursed by DOPPW to them as per existing TA/DA Rules.

7.3 Accommodation in New Delhi: Concerned Ministry/ Department/ Organization will arrange accommodation for Anubhav awardee/Jury Certificate Winner and accompanying persons (if any).

8. With respect to the National Anubhav Awards Scheme, 2026, the decision of the Department of Pension & Pensioners' Welfare, Ministry of Personnel, Public Grievances and Pensions, Government of India shall be final.


Sub: National Anubhav Awards Scheme-2025.

A platform called "Anubhav" has been introduced by the Department of Pension and Pensioners' Welfare (DOP&PW) whereby retiring/retired Government servants can upload a write up showcasing outstanding work done by them during service period. .

2. In this connection, DOP&PW are conducting meetings wherein it has been advised that Railway being a large organization of Govt. of India, last year only two awardees were selected for National Anubhav Awards, 2024. From this year, apart from the employees of Central Govt., employees of CPSE's & Public sector banks who are going to retire in next 8 months or who retired within 3 years are also eligible for submission of anubhav write-ups. Accordingly, under the said scheme retiring/retired employees of Railway PSUs may submit their Write-ups from 8 months prior to retirement up to 3 years after retirement. All write-ups submitted from 01.04.2024 up to 31.03.2025 shall be eligible to be considered for National Anubhav Awards, 2025. Guidelines in this regard have already been forwarded vide letter dated 31.01.2025. DOP&PW is pressing hard that M/o Railways may motivate their retired/retiring employees personally by sending SMS/emails in connection with the theme of National Anubhav Award Scheme, 2025 for more employee's participation in submitting their Anubhav experiences on the portal so that wide publicity may be given to the scheme.

3. Therefore, it is requested that DRMs may be directed to contact personally with Railways employees/retirees as well as attached subordinates offices for the same. Further MDs /CMDs of Railway PSUs may also contact personally with their employees/retirees through conducting VC or making whats groups for motivation about the scheme. A copy of equivalence of pay scales between central govt. employees as well as employees of Railway PSUs for the purpose of eligibility of Anubhav award scheme 2025 is also enclosed.

National Anubhav Award scheme,2025 has been notified. For the first time, apart from the employees of Central Government, employees of Central Public Sector Enterprises (CPSEs) and Public Sector Banks who are going to retire in next 8 months or who have retired within 3 years are also eligible for the submission of Anubhav write ups.

2. As per the Scheme, the published write ups will be divided into three categories and the same would be examined for 05 Anubhav Awards and 10 Jury Certificates. The category wise division of the Anubhav Awards and Jury Certificates is as under:

3. Further, the Anubhav write-ups pertaining to these three categories are to be evaluated with different marking system.

4. Certain Ministries/Departments administering Public Sector Banks/ Public Sector Enterprises have enquired about the equivalence between the pay scales applicable to the employees of CPSEs i.e. Industrial Dearness Allowance (IDA) and to the employees of Public Sector Banks i.e. PSB Pay scales vis-à-vis the pay scale equivalent to Central Dearness Allowance (CDA) applicable to Central Government Employees.

5. In this regard, it is informed that to draw the equivalence among three pay scales, an enquiry has been made on the web-sites of certain organizations which are as under:



INTRODUCTION TO ANUBHAV PORTAL

The Anubhav Portal was launched by the Department of Pension and Pensioners' Welfare at the behest of our visionary Prime Minister in March, 2015 to provide an online system to the retiring and retired employees for showcasing their commendable work during service. Their experiences of working in the Government and their suggestions in these write ups provide an opportunity for improvement in governance.

The portal has celebrated its illustrious 10 years in 2025 with more than 12,500 write-ups published on the portal, showing the growing role of this portal. Till 2025, 64 Anubhav Awards and 29 Anubhav Jury Awards have been conferred in 8 ceremonies.

In recent years, several initiatives have been undertaken to realize the objectives behind the portal. In 2022, Anubhav Awardees' Speak, a webinar series was introduced, wherein the Awardees address the soon-to-be-retiring employees and share their experiences and also encourage them for participation in the scheme. In 2023, 10 Anubhav Jury Awards, apart from 05 Anubhav Awards were introduced to ensure wider participation. Also, specific number of awards were assigned to the three pay scale groups to ensure participation even from lower rung officials. In 2024, parameter specific marking system was introduced for bringing objectivity in the assessment process and employees of 12 Public Sector Banks and Central Public Sector Enterprises were also included in the scheme for an increased participation. In 2025, specific marks to the 'feedback/suggestions' have been assigned in the marking system.

OVERVIEW OF NATIONAL ANUBHAV AWARDS SCHEME, 2026

FLYER

ELIGIBILITY

- 01 Employees/Pensioners of Central Government, Central Public Sector Enterprises (CPSEs) and Public Sector Banks (PSBs) are eligible for submitting their write-ups. The concerned administrative Ministry/Department under which CPSEs/PSBs fall, will manage the submission and publication of write-ups.
- 02 The employees who are going to retire in next 8 months or pensioners who have retired in the period not more than 3 years. It is independent of the financial year.

TIME PERIOD & DISTRIBUTION

- 03 All Anubhav write- ups published on the Anubhav Portal between 1st April, 2025 and 31st March, 2026 will be considered for the Anubhav Awards/Jury Certificates, 2026.
- 04 The pay scale wise division of the 05 Anubhav Awards and 10 Jury Certificates is as under:

- ▶ The final authority to publish the write-up is HOD of concerned Ministry/Department.

PROCESS AFTER PUBLICATION

- ▶ Published write-up is subjected to 2-tier examination process by DOPPW.
- ▶ Marks are assigned as per marking system.
- ▶ 05 Best write ups are selected for Anubhav Awards and other 10 outstanding for Jury Certificates.
- ▶ Anubhav Award Winner : Medal, Certificate and Cash prize of ₹ 10,000/-
- ▶ Jury Certificate winner: Medal and Certificate.
- ▶ The winners are conferred by Hon'ble MOS (PP) at the national level event.



NATIONAL ANUBHAV AWARDS SCHEME, 2026

On the directions of the Hon'ble Prime Minister of India, Department of Pension & Pensioners' Welfare had launched an online platform 'Anubhav' in March 2015 for sharing the experiences of retiring/retired government employees while working with the Government. It is a scheme for retiring/retired employees to showcase their significant achievements during service period. The platform serves as a repository of practical insights and replicable best practices that can guide and inform future governance. This will prove an invaluable tool for documenting the administrative history of India through personal memoirs.

2. Thereafter, an Annual Awards Scheme to incentivize and encourage retiring/retired employees to submit their experience through write-ups was introduced in 2015. 59 Anubhav Awards and 19 Jury Certificates have been conferred till 2024 and 5 Anubhav Awards and 10 Jury Certificates for 2025 will be conferred. Further, enriching the 'Anubhav' initiative, the Department of Pension & Pensioners' Welfare (DOPPW) organizes a monthly webinar series titled 'Anubhav Awardees' Speak'. This platform features selected awardees who have contributed exceptional write-ups to the Anubhav portal. Through these sessions, awardees share their insightful experiences, innovative practices, and noteworthy contributions made during their tenure in government service. Hitherto, 21 webinars have been held in which 30 Awardees have presented their experiences.

3. NATIONAL ANUBHAV AWARDS SCHEME, 2026

3.1 For the year 2026, the scheme aims to recognize the contribution of eligible Government employees in the following categories:

- i. Accounts
- ii. Administration
- iii. Good Governance
- iv. Government process re-engineering
- v. Information Technology
- vi. Research
- vii. Simplification of procedures
- viii. Learning from Failures
- ix. Public Dealing
- x. Contribution to his/her field work
- xi. Instances of great strength/valor/bravery
- xii. Constructive feedback or suggestion to improve the line of work, he/she was part of; and
- xiii. Any other category decided by the Committee

3.2 For the year 2026, it has been decided to confer Anubhav Awards to 5 (five) best write-ups and 10 (ten) Jury Certificates will be presented to other outstanding write-ups to promote wider publicity and participation in National Anubhav Awards scheme, 2026. Assessment of the write-ups would be structured on premises as stated in para 6 of the Scheme.

3.3 The Awards shall be conferred by Hon'ble MOS (PP) at a National Level event.

4. ELIGIBILITY

The employees of Central Government, Central Public Sector Enterprises (CPSEs) and Public Sector Banks who are going to retire in next 8 months or who have retired within 3 years are the 'eligible employees' for the submission of Anubhav write ups. All the Anubhav write-ups published on the Anubhav Portal between the period 1st April, 2025 and 31st March, 2026 will be considered for the Anubhav Awards/Jury Certificates, 2026 under National Anubhav Awards Scheme, 2026.

5. ROLE AND RESPONSIBILITIES OF THE MINISTRY/DEPARTMENT/ORGANISATION

5.1 Initiatives should be taken to sensitize the retiring or retired employee for submitting their write-ups through SMSs and emails. FAQs, steps to fill Anubhav write-up, selected write-ups for guidance, short film on Anubhav Awardees and citation booklets have been put up on the Anubhav Portal. Their adequate publicity may be done amongst the eligible employees.

5.2 The HOOs and HODs should act upon the write-ups reflected under the head- 'Write-ups Yet to be Published' on the Anubhav Portal on regular basis.

5.3 HOO and HOD may refer the FAQs put up under the Head- 'Organization' on the Portal.

6. PROCESS OF SHORTLISTING ANUBHAV AWARDS AND JURY CERTIFICATES

Step 1- The eligible retiring or retired government employee can visit the Anubhav Portal at the following URL: <https://pensionersportal.gov.in/Anubhav/>. Thereafter, basic details along with the write-ups, not in more than 5,000 words and appropriate attachments, wherever required, shall be submitted by the retiring/retired government employee on the Portal. At this stage, the write ups will be visible under the category of 'Write-ups yet to be published' on the Anubhav Portal.

Step 2- The write ups so submitted shall be assessed and approved by concerned Ministry/Department/Organization. After approval, the write-ups shall be visible under the category of 'Write-ups published' on the Anubhav Portal.

Step 3- Selection process: The published write-ups will be divided into three categories and the same would be examined for 05 Anubhav Awards and 10 Jury certificates. The category wise division of the Anubhav Awards and Jury Certificates is as under:

Thereafter, the write-ups will be subjected to 2- tier examination.

Tier-II: Next round of shortlisting for the 5 (five) Anubhav Awards and 10 Jury Certificates shall be done by an Evaluation Committee (EC), chaired by the Joint/Additional Secretary (Pension & PW). The Composition of Evaluation Committee (EC) is as below:

Step 4- Evaluation Committee will finalize name of awardees and later 'No Objection Certificates' (NOCs) of the selected awardees will be obtained from concerned Ministry/ Department/Organization and IB.

Step 5- Recommendations of the Evaluation Committee, after approval of Secretary (Pension & PW) and necessary clearances, shall be put up to the Hon'ble MOS (PP) for approval.

7. DETAILS OF AWARD AND OTHER ENTITLEMENTS

7.1 Each Anubhav Awardee will be felicitated with a Medal, a Certificate and a Cash Prize of Rs. 10,000/- (remitted through digital transfer to Awardees account) whereas a Jury Certificate Winner will be presented with a Medal and a Certificate.

7.2 Travelling Allowance: TA to the Anubhav Awardee/Jury Certificate Winner (as per last entitlement) and one accompanying person, travelling for Award ceremony to New Delhi and back, will be reimbursed by DOPPW to them as per existing TA/DA Rules.

7.3 Accommodation in New Delhi: Concerned Ministry/ Department/ Organization will arrange accommodation for Anubhav awardee/Jury Certificate Winner and accompanying persons (if any).

8. With respect to the National Anubhav Awards Scheme, 2026, the decision of the Department of Pension & Pensioners' Welfare, Ministry of Personnel, Public Grievances and Pensions, Government of India shall be final.
