Sub: Operation of non-gazetted Zonal Railways / PUs / Railway PSUs post in Railway Board.

It has been observed that various Directorates in Board's office are requesting / availing the services of non-gazetted staff from Zonal Railways / PUs / Railway PSUs in Board's office either on loan basis or by transferring the post or through some informal arrangement.

2. In this context, it is informed that on the directions of Hon'ble MR, a review of non gazetted posts of Zonal Railways / PUs / Railway PSUs being operated in Board's office was carried out about a year back and a number of such posts were transferred back to the Zonal Railways / PUs / Railway PSUs, as decided at the level of Board (MS & FC). Thereafter, no new non-gazetted post has been created in Board's office utilising any Zonal Railways / PUs/ Railway PSUs post. Further, there is no likelihood of creating more such posts in Board's office in near future.

3. In view of above, all officers in Board's office are advised to desist from requesting / availing the services of staff of Zonal Railways / PUs / PSUs in Board's office either on loan basis or by transferring any new post or through any informal arrangement.
