Chapter II, Section 'A'---Rules governing promotion of Group 'C' staff to Group 'B' posts.

1. **Para 203.1**

For the existing para 203.1, substitute the following:

Group 'C' employees working in Level 6 and above in Pay Matrix with 3 years of non-fortuitous service in Level 6 and above in Pay Matrix (including non-fortuitous service rendered in the corresponding pre-revised grade pay) are eligible for Group 'B' Selections(70% quota) in the departments having organised services.

For Selections for promotion to Group 'B' posts in Accounts department, Group 'C' employees fulfilling the abovementioned condition should also have qualified the Appendix-3 IREM Examination.

अध्याय II, खंड 'क' --- समूह 'ग' कर्मचारियों की समूह 'ख' पदों पर पदोन्नति को शासित करने वाले नियम.

1. पैरा 203.1

मौजूदा पैरा 203.1 को निम्नलिखित से प्रतिस्थापित किया जाए :

समूह 'ग' के वे कर्मचारी, जिन्होंने पे मैट्रिक्स के लेवल 6 या उससे उपर के लेवल में 3 वर्ष की अनाकस्मिक सेवा की हो (तदनुरूपी पूर्व संशोधित ग्रेड पे में की गई अनाकस्मिक सेवा सहित) तथा पे मैट्रिक्स के लेवल 6 या उससे उपर के लेवल में कार्यरत हैं, संगठित सेवाओं वाले विभागों में समूह 'ख' में चयन (70% कोटा) हेतु पात्र हैं।

लेखा विभाग में समूह 'ख' में पदोन्नति के लिए चयन हेतु उपरोक्त शर्तों को पूरा करने वाले समूह 'ग' कर्मचारियों को परिशिष्ट-3 भारतीय रेल स्थापना नियमावली जिल्द-1 परीक्षा भी उत्तीर्ण करनी होगी ।
