
Sub: Grant of Additional Benefits on death/disability of Government servants covered under National Pension System (NPS) – reg

1. The Hon'ble Member (Accounts) vide No. RLS/HR/19 dated 29.05.2019 directed that the existing rules governing procedure for grant of Additional Benefits on death/disability of Government servants covered by New Pension Scheme (NPS) – Institutions, issued and effective from 01.11.2014, will be applicable to large Government Servants who joined Government service on or after 01.11.2014 and will have effect from the same date i.e. 01.11.2014. Further, the Member (Accounts) vide letter No. 2018/HR/HR/1 dated 27.01.2018, in which Pension Fund Regulatory and Development Authority of its and Withdrawals under NPS (Regulation 2018) notified vide Gazette notification dated 14.05.2018, was adopted and approved by Railway Board for the purpose that in the subsequent of the family members of the deceased subscriber upon his death, avails the option of additional benefit on death/disability provided by the Government, the Government and Government to adopt the existing provisions of the Pension System of subscriber in full.

2. Petitioners were received as this office seeking justification, grant of the gratuity as well as gratuity and provident fund pension, instead of NPS corpus is also apparently irregularity for the same reason, report of NPS has already been drawn in the deceased employee's ledger books before Pension Board vide No. 2018/HR/HR/1 dated 27.01.2018. The date of application for additional benefit is retrospective, whether it is from the date of application received or from the date of issue of Board's letter dated 27.01.2018. Also, the date of issuance of pension plan is also retrospective of NPS corpus. The amount of gratuity and provident fund pension will be computed by Railway Board as per the rules applicable to the interest of the corpus is to be granted from the date of receipt of application received the date of issue of Board's letter dated 27.01.2018.

3. The above said facts are suggested to be taken with the consent of Railway Board and Government of India vide letter No. RLS/HR/19 dated 29.05.2019 and Ministry of Railways vide letter No. RLS/HR/19 dated 29.05.2019.
