

Railway Board's letter dated 03-03-2020 (RBE 28 / 2020) regarding coverage under Railway Services (Pension) Rules 1993 in place of National Pension System to those Railway Employees whose selection for appointment was finalized before 01-01-2004 but who joined Railway Service on or after 01-01-2004 was circulated as PBC 37 / 2020 vide this office letter of even number dated 05-03-2020.

As per para 4/5 of DOP&PW's Memorandum dated 17-02-2020 circulated under the above reference, a one time option has to be exercised by such NPS employees on or before 31-05-2020 on coverage under CCS (Pension) Rule 1972 / Railway Services (Pension) Rule 1993 in place of National Pension System.

To have a uniformity in exercising the option by the employees the option form to be obtained from them is enclosed. The same may be circulated to all such employees under clear acknowledgement and further action may be taken to process the case.
