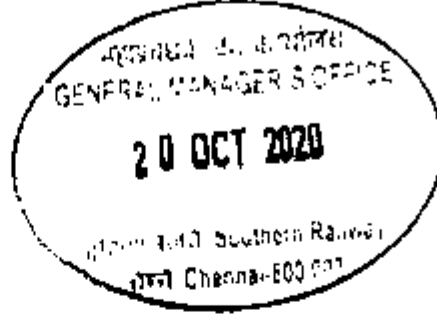


Ref: Board's letter of even number dated 30.01.19 and 22.06.20

Attention is invited to this Ministry's letter of even number dt 30.01.19, vide which it has been advised that reporting/reviewing/accepting authorities can write the APAR after one month of retirement.

2 Now, it has been decided that the reporting/reviewing/accepting authorities retiring from 30.06.20 to 31.10.20, shall be allowed to record part PAR for the year current year 2020-21 beyond extant timeline of one month after their retirement but within 31.12.20. However, for reporting/reviewing/accepting authorities retiring in November 2020 or thereafter, Board's letter of even no. 30.01.19 shall continue to be applicable.

3 The APAR already closed may be treated as final.

4 Necessary action may be taken accordingly
