

In this Office letters cited under reference were received from the competent authority in the Ministry of Health & Family Welfare, Government of India, regarding the mutatis-mutandis adoption of provisions contained in Ministry of Health & Family Welfare's OM number Z15/25/12/2020 DIR CGHS dated 27.09.2020 and extension thereof up to 31.12.2020 for Railway medical beneficiaries also with effect from 01.10.2020. The implementation of the provisions contained in Ministry of Health & Family Welfare's OM dated 27.09.2020 has been approved by the Railway Board on 21.12.2020. The Competent Authority in the Ministry of Railways has decided to extend the implementation of the scheme up to 31.12.2020 mutatis-mutandis for Railway medical beneficiaries also.

The Railway Board has directed railway health facilities, hospitals and railway medical stores to purchase the OPD medicines through railway health facilities as per schedule instead of purchasing from market.

This order is issued with the concurrence of Finance Director, Railway Board.
