

**Sub:- Fixation of pay of Running Staff in 7<sup>th</sup> CPC while working on temporary drafting basis on stationary post-reg.**

It has come to notice through a representation submitted by some Loco Pilots (Mail) (presently working in Board's office on temporary drafting basis) that Running Staff on stationary posts in ZRT/BSL and ETC/Kanpur and other places are getting pay as per RBE No.99/2017, dt. 21.08.2017, which is contrary to the policy instructions on the subject.

The policy instructions on the subject as contained in Rule 924 (i) (d) of IREM-1 clearly states that 30% of the basic pay of running staff shall be reckoned as pay for fixation of pay in Stationary Posts. The Staff in non-running posts do not earn Running Allowance and as such their pay fixation cannot be done in terms of RBE no. 99/2017 dated 21.08.2017. Therefore, their pay fixation would be done as a non-running staff, in terms of Annexure-A of RBE no. 93/2016 dated 02.08.2016. However, after repatriation to their parent cadre as a Running Staff, their pay would be re-fixed as per RBE no. 99/2017 on pro-forma basis without any arrears.

In view of the above position, Railways are requested to examine the matter and take necessary action as per above clarifications.
