


Sub:- Conducting of Selection to fill up the posts in the cadre of
PGT/TGT-Hiringservices of professors/Experts from outside the
Railways-Regarding.

Attention is invited to Para-218 of IREM Volume-I (Revised Edition 1989) First Re-Print Edition-2009, wherein detailed procedure for constitution of selection Board has been explained for conducting the selection of any post under Zonal Railways. It has now been brought to the notice of Board that the Railways/Production Units are facing difficulties in filling up the posts of TGT/PGT in Railways' schools due to non-availability of experts in the concerned subject. This leads to delay, causing hindrance in study of curriculam within academic session and also creates resentment among TGTs/PGTs because of their non-promotion whenever it becomes due.

2. In the light of the above, the matter has been considered. It has been decided that Departmental Selection Board should consist of three JAG Level officers including Educationists/Experts in the concerned subject as members. In case of non-availability of such expert in the Railway itself or on the contiguous Railways/Railway Institutions, the services for this purpose may be taken from outside the Railways i.e. from recognized government educational institutions in the adjoining areas. The experts hired for setting of Question papers and evaluators hired for evaluations there-of should be two different individuals in case such hiring of service is done. They shall not in any way form part of Selection Board/Committee. The remuneration to their services may be paid according to the provisions contained for departmental Selection in Board's letter No. E(G)/2001/HO/1-7 dated 03.03.2009 and 29.12.2009 or as per extant policy in force at relevant time where their services are hired for evaluation/questions paper setting.

Subject : Grant of honorarium to the Railway Officers/Staff for setting of question papers & evaluation of answer sheets for Limited Departmental Competitive Examination held for promotion from Group 'C' to Group 'B'.

Please refer to Board's letters of even number dated 15.10.2001 (*Bahri's RBO 205/2001, p-217*) & 03-05-2002 (*Bahri's RBO 60/2002, p-74*) vide which the amount of honorarium for evaluation of answer books and setting of question paper in connection with Limited Departmental Competitive Examination held for promotion from Group 'C' to Group 'B' were last revised. The matter regarding enhancement of these rates has been under consideration

of the Board and it has been decided that the rates of honorarium for the same shall be as indicated below:-

- (i) For setting of question paper - Rs. 1000/- per question paper.
- (ii) For evaluation of answer sheet - Rs. 50/- per answer sheet.

Honorarium shall be paid for evaluation of Answer Book only if they are evaluated and returned within one month.

Subject : **Grant of honorarium to the Railway Officers/Staff for setting of question papers & evaluation of answer sheets for Limited Departmental Competitive Examination held for promotion from Group 'C' to Group 'B'.**

Reference instructions contained in Board's letter of even number dated 03.03.2009 (RBE 44/2009) under which the rates of honorarium payable to the Railway officers/staff for setting of question papers and evaluation of answer sheets for Limited Departmental Competitive Examination held for promotion from Group 'C' to Group 'B' have been enhanced. It has inter-alia been stipulated in the said instructions that **honorarium shall be paid for evaluation of answer sheets only if they are evaluated and returned within one month.**

In view of the practical difficulties expressed by some Railways for returning the evaluated answer sheets within one month especially in cases where the number of answer sheets to be evaluated is very large, the matter has been reviewed by the Board and it has been decided that the prescribed time limit of one month may be relaxed to two months in such cases where the number of answer sheets to be evaluated exceeds 250.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
