OFFICE MEMORANDUM

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners Revised rate effective from 01.07.2018.

The undersigned is directed to refer to this Department's OM No. 42 on 2018 P&PW(G) dated 22,03,2018 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Covernment pensioners/family pensioners shall be enhanced from the existing rate of 20 n to 90 over 01,07,2018.

- 2. These rates of DR will be applicable to (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt, absorbed pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years (ii) The Armed Forces Pensioners (vi) Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners family pensioners (v) Pensioners who are in receipt of provisional pensioners (vi) The Burma Civilian pensioners family pensioners and pensioners family and displaced Government Pensioners from Burma Pakistan, in respect of whom pages have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.69/2017
- 3 The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1000 as amended vide this Department's OM No. F.No. 38/88/2008-P&PW(G) dated 9. July 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these distractions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23-14 dated the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958 GA-64 (ii) (CGL) 81 dated the 21 May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.

- 8. In their application to the pensioners family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 9. This issues in accordance with Ministry of Finance, Department of Expenditure's OM No. 1/2/2018-E.H(B) dated 07th Sept.2018.
