Details of non-gazetted post falling in different medical classifications over Indian Railways was circulated vide Board's letter cited under reference.

One of the zonal Railways has requested for upgradation of medical fitness category of Technicians and Helpers of Track Machine Wing of Civil Engineering Department from B-1 to A-3 medical standard. The issue was also raised by the General Manager of the zone during the video conference held by CRB on 27.11.2017. After detailed consideration in the matter, Civil Engineering Directorate has advised that the proposal of the zone is justified and needs consideration as it involves safety aspect.

After careful consideration in the matter in consultation with Safety Directorate, it has been decided, with the approval of Board that the medical classification of Technicians and Helpers of Track Machine Wing of Civil Engineering Department be upgraded from B-1 to A-3 medical classification.

Accordingly, the posts of Technicians and Helpers of Track Machine Wing of Civil Engineering Department will henceforth be categorized in medical classification A-3. However, existing Helpers of Track Machine Wing of Civil Engineering Department shall be eligible for promotion to Technicians even though they are certified in B-1 category as per the present criteria.
