

Sub: Travel entitlement of DGs & GMs who have been granted  
Apex Scale of ₹80,000/- (VI-CPC) and placed in Level 17 of 7<sup>th</sup> CPC.

Ref: Board's letter No. E(W)2008/PS5-1/38 dated 03.02.2011.

Consequent to upgradation of the posts of DGs to Apex Scale (₹80,000/- VI-CPC and placed in Level 17 of 7<sup>th</sup> CPC) and grant of same scale to some of the GMs on non-functional and personal basis, it has been decided that the travel entitlement of the officers falling in this category will be at par with the officers holding the Apex Pay Scale, as contained in Board's letter under reference. Accordingly, the grouping of officers indicated in Row-3 under Column-1 of Annexures - 1 & 2 should be read as indicated in the following tables:-
