Sub: - Discontinuation of the scheme of reciprocal travel concession
arrangement with the Railways of foreign countries.

Ref: - Railway board's letter No. E(W)2008/PS5-1/22 dated 17-01-2019.

It is hereby notified to all concerned that as decided by Railway Board, the IRCA booklet on "Concessions on Railways of Foreign Countries to Employees of Indian Railways" which was last published in January 1999 would cease to operate on Indian Railways w.e.f. 31-01-2019.

The Board's above orders taken in view of inadequate response for the renewal of mutual agreement for travel concessions admissible on Railways of Foreign Countries to employees of Indian Railways. It has been observed that inspite of repeated postal and e-mail communications made by IRCA, seeking inputs for continuation of the reciprocal arrangement from participant Foreign Railways listed in the booklet through the Embassies/High Commissions of respective countries in India and also through the Embassies/High commissions of India in those Countries, no encouraging response has been received in IRCA. The Railways system in many of the Foreign Countries who were participants of the scheme have also been privatized since the last edition of the booklet.

Accordingly, all the Zonal Railways/Production Units/ PSUs are advised not to issue Certificates to its officers/employees under the scheme of reciprocal travel concession and such certificates issued by other Foreign Railways which were participants of the scheme hitherto will not valid for travel over Indian Railways w.e.f. 31-01-2019.
