Kindly refer to Ministry of Railways' letter No. E(MPP)/2012/3/28 dated 05.10.2017 (RBE No. 147/2017) wherein Ministry of Railways had communicated revision of rates of training allowance and abolition of Sumptuary allowance.

2. Pursuant to the recommendation of 7^{th} CPC, Ministry of Finance, Department of Expenditure vide OM No. 11-1/2016/E.II 8 (7^{th} CPC) dated 22.09.2017 has conveyed the ceiling of office expenditure on hospitality.
