In terms of Board's letter 21.09.1982 and 28.08.1997, the facility of Special Casual Leave and Special Passes were granted to the office bearers of All India Scheduled Castes and Scheduled Tribes Railway Employees Association (AISCSTREA) and All India OBC Railway Employees Federation/Association (AIOBCREF/A) as and when they are required to attend the Informal Meetings at the Zonal Railways/Railway Board's level.

- 2 However, one of the railway has sought clarification on Special Casual Leave to be granted to office bearers of the recognized welfare Associations viz. AISCSTREA and AIOBCREF/A for attending the Informal Meeting called for by the Railway Board/Zonal or Divisional Railway Administration.
- 3 The matter has been examined and it has now been decided that 2 days Special Casual Leave should be granted (one day for Informal Meeting and one day prior for their internal meeting) plus the journey time to the office bearers of All India Scheduled Castes and Scheduled Tribes Railway Employees Association and All India OBC Railway Employees Federation/Association for attending the Informal Meeting as and when called for by the Administration at Railway Board/Zonal/Divisional level

Sub: Grant of facilities to All India OBCs Railway Employees Association.

Grant of facilities to Railway Employees Association representing OBC employees has been under consideration of the Ministry of Railways. It has been decided that one such Association in each Zonal Railway/Production Unit who full! the following conditions and who apply to the General Manager may be given the facilities as detailed in para 2.

- The Association should be genuine representatives of a majority of Railway employees belonging to the OBC.
- (ii) The aims and objectives of the Association should eleavis being out that a local welfare Association of genuine. OBC Railway employees and the membership should be open to all categories of OBC Railway serving employees.
- (iii) The constitution/bye-laws of the Association should provide for election by secret ballot of the office hearers at the Zonal level and the Divisional level.
- (iv) The Constitution/Bye-laws should provide that serving CBC Pailway employees can only be office bearers of the Association.
- (v) It should be provided for in the bye-laws that Association will not indulge in trade, union activities.
- (vi) The registered office of the Association should be at the headquariers of the Fonst Railway/Production Unit.

- 2. An Association satisfying the above conditions and who apply to the Cia. 'Manager of the Zonal Railway/Production Unit may be given the following factories:
- a) The office bearers of the Association can have interview with the Liaison Officer for mitigating the grievances of the OBC Railway employees in matters regarding appointment harassment discrimination in providing reservation and other benefix, including concessions/relaxation s to the OBC employees.
- b) Acknowledgement of communication received from the said Association.
- c) Keeping the said Association advised about the Government's policy of reservation for OBCs.
- d) Supply of establishment policy circulars/letters on policy matters of interest to OBC railway employees.
- e) Holding of informal meetings with the representatives of the Association if so desired by them not more than twice in a year at the Zonal Production Unit/Divisional levels.
- 1) For attending such informal meetings, the representatives of the Association not more than 20 in number may be granted Special Casual Leave, and journey passes.
- g) In the informal meetings, notes of discussions may be taken but formal minutes need not be issued. However, copy of the record note of discussions may be given to the Association. In the subsequent meeting when held, the action taken on the previous note of discussions may be apprised to the Association.
- h) Not more than for 3 office bearers of the Association may be issued with the identity cards/gate passes where the entry is controlled by the gate pass system.
