Sub: Rate of Dearness Allowance applicable w.e.f. from 01.01.2018 to Railway employees continuing to draw their pay in the pre-revised pay scale/grade pay as per 6<sup>th</sup> Central Pay Commission.

Please refer to this Ministry's letter of even number dated 17.11.2017 (S.No. PC-V1/379, RBE No.169/2017) revising the rates of Dearness Allowance w.e.f. 01.07.2017 in respect of railway employees continuing to draw their pay in the pre-revised pay scale/grade pay as per 6<sup>th</sup> Central Pay Commission.

- The rate of DA admissible to railway employees of above category shall be enhanced from the existing rate of 139% to 142% w.e.f. 01.01.2018.
- The provisions contained in Paras 3,4 & 5 of this Ministry's letter of even number dated 09.09.2008 (S.No. PC-VI/3, RBE No.106/2008) shall continue to be applicable while regulating Dearness Allowance under these orders.
